- 2. I represent that my pet is in good health, is current on all required vaccinations (including, without limitation, DHLPP, Rabies, Bordatella), is free of fleas, ticks, and lice, and as not been ill with any viruses in the last 30 days.
- 3. I agree to allow a12-day waiting period after my pet as had their vaccinations to allow the vaccines to reach full protection potential and to ensure my pet has not has any negative reaction to the vaccines.
- 4. I understand that while my pet is fully vaccinated that vaccines are not guaranteed and there is a small risk that my pet may contract a contagious disease or illness. I agree that should this occur I am responsible for my own pet's care and medical attention.
- 5. I understand that, although all pets are fully supervised, that incidents of injuries may occur from playing with other pets, which may include, but not limited to, bites, scrapes, scratches, and sprains. I further understand that due to the way that pets (dogs, cats, etc.) interact with one another, injuries may occur.
- 6. I represent that my pet is sociable and has not harmed or shown threatening behaviours towards any person or any other pet. ALK Pet Services reserves the right to remove my pet from the play area and place my pet in a separate holding area should my pet display any unwanted behaviours, at the sole discretion of ALK Pet Services.
- 7. I agree to disclose any previous or current medical issues or concerns of my pet so that ALK Pet Services staff can make a determination of suitability for daycare or offsite boarding.
- 8. I agree that toys/objects I provide may get broken during my pet's time in ALK Pet Services Care and that they are in no way financially responsible for replacing any items provided.
- I agree to free ALK Pet Services from any liability should my pet injure another pet or person or destroy an object and accept medical and legal and financial responsibility for my pet's actions.
- 10.I agree that my pet may have pictures taken and/or may be recorded on camera and its images may be used for ALK Pet Services promotional material.
- 11.I agree to pick up my pet at the agreed upon time. Should I fail to do so I understand I will be charged late fees in the amount of \$10 for every hour. I understand that appointments cancelled within less than 48 hours of the start time do not get a refund. Any appointment cancelled within 6 days of the start time will also be subject to an automatic 25% cancelation fee. 25% of the total cost of the appointment will be charged.
- 12. In special circumstances, ALK Pet Services may charge more than usual for things like taking care of large breeds, behavioural issues, damage done to my home by a pet while they are in my care, administering medication, etc.
- 13. Holiday services will cost more than regular appointments. Appointments made on holidays or on days leading up to certain holidays will cost an additional \$20 more than usual.

has up to date vaccines, and has not harmed or shown aggressive or threatening behaviour towards any person or any other animal in the past.

- 15. While my pet is in the care and custody of ALK Pet Services, if I am unreachable in the event of an emergency, I hereby authorize ALK Pet Services staff to contact the identified veterinarian or any other accessible vet clinic at its sole discretion should any injuries require medical attention. I agree to be financially responsible for any and all costs in connection with, veterinary, medical or other treatment given. I am aware and understand that I should carry my own pet insurance.
- 16. I hereby release and agree to save and hold harmless, ALK Pet Services, it's directors, officers, shareholders, employees, assistants, members and agents from any and all liability, claims, including claims of ALK Pet Services negligence, suits, actions, loss, injury or damage of any nature or kind, or death, or for any liability, claims, suits, actions, loss, injury, damage which I or my pet(s) may sustain or which may be caused in any way by my pet(s) or the pets that reside at 320 5 Street NE Slave Lake Alberta, Canada. I specifically, without limitation, agree to fully indemnify ALK Pet Services and any representatives for any and all such liability, claims, suits, actions, losses, injury, damage or death.
